

**TOWN AND COUNTRY PLANNING (GENERAL PERMITTED DEVELOPMENT)
(ENGLAND) ORDER 2015 (the "Order")**

DIRECTION MADE UNDER ARTICLE 4(1) TO WHICH SCHEDULE 3 APPLIES

WHEREAS THE LONDON BOROUGH OF ISLINGTON being the appropriate local planning authority within the meaning of Article 4(5) of the Town and Country Planning (General Permitted Development) (England) Order 2015, is satisfied that it is expedient that development of the description(s) set out in the First Schedule below should not be carried out on the land described in the Second Schedule below, unless planning permission is granted on an application made under Part III of the Town and Country Planning Act 1990 as amended.

NOW THEREFORE the said Council in pursuance of the power conferred on them by Article 4(1) of the Town and Country Planning (General Permitted Development) (England) Order 2015 hereby directs that the permission granted by Article 3 of the said Order shall not apply to development specified in the First Schedule hereof in respect of the land described in the Second Schedule hereof:

FIRST SCHEDULE

In respect of land described in the Second Schedule

Being development comprised within Schedule 2 Part 3 Class PA of the said Order namely:

"Development consisting of a change of use of a building and any land within its curtilage from a use falling within Class B1(c) (light industrial) of the Schedule to the Use Classes Order to a use falling within Class C3 (dwellinghouses) of that Schedule"

and not being development comprised within any other class.

SECOND SCHEDULE

Land shown shaded grey on the plan of the London Borough of Islington attached for the purposes of identification of the general locations only

Land shown shaded grey on the plans labelled as follows (such labelling following the areas marked on the plan of the London Borough of Islington as a whole) and attached to this Direction:

- 1 Archway
- 2 Finsbury Park
- 3 Lower Holloway
- 4 Highbury
- 5 King's Cross
- 6 Angel and Canonbury
